

TAX LEVY ORDINANCE

ROAD DISTRICT

ORDINANCE NO. 2023-4

An ordinance levying taxes for all road purposes for Taylorville Township Road District Christian County, Illinois, for the tax year 2023 , collectable in 2024.

BE IT ORDAINED by the Board of Trustees of Taylorville Township, Christian County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Taylorville Township Road District on December 13th, 2023 does hereby determine and declare that the sum of Five Hundred Thirty Thousand Seven Hundred Seven Dollars (\$530,707.00) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

- General Road Fund , Permanent Road Fund
- Insurance Fund , Joint Bridge Fund
- IMRF Fund , Equipment & Building Fund
- Social Security Fund , _____

for the year 2023_.


