TOWNSHIP

ORDINANCE No. 2023-3

An ordinance levying taxes for all town purposes for Taylorville Township,
Christian County, Illinois, for the tax year 2023 , collectable in 2024.

BE IT ORDAINED by the Board of Trustees of Taylorville Township,
Christian County, Illinois, as follows:

SECTION 1: That the sum of Three Hundred Thirty-six thousand six hundred seventy-eight _____
_____ Dollars (\$ 336,678.00) are hereby levied upon all
property subject to taxation within the Township as that property is assessed and equalized, in order to
meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted
by the people in accordance with the law, for such purposes as:
