An ordinance levying taxes for all town purposes for Taylorville Township,
Christian County, Illinois, for the tax year 2025, collectable in 2026.

BE IT ORDAINED by the Board of Trustees of Taylorville Township,
Christian County, Illinois, as follows:

SECTION 1: That the sum of Three Hundred Forty-two Thousand, Seven Hundred
Dollars (\$ 342,700.00) are hereby levied upon all

property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

General Town Fund, General Assistance Fund,

Insurance Fund, IMRF Fund,

Social Security Fund,

for the year 2025.
